

**Meeting Notes from the
General Membership Meeting
June 1, 2021**

-Meeting called to order at 7:15pm

-The General Membership will be voting on four items tonight.

-Who is a member? If you have a student in the band program, you are a member.

Item One: 2021-2022 Colgan Band Boosters Budget

- The Band Boosters operates on a balanced budget
- The current band budget (2020-2021) is still active until July 31, 2021
- The current balance in the checking account is \$17,533.35
- The current balance in the savings account is \$92,204.13
- For the 2020-2021 school year we moved \$35,918 to savings and bought 30 brand new marching band uniforms
- We anticipate 2021-2022 to be a normal year

Let the record show that the proposed budget for the 2021-2022 school year has passed by a simple majority. The budget will be posted on the Colgan Band website.

Item Two: Amendment to Article VI (A) (2)

The Executive Board has proposed amending the bylaws as follows:

Article VI (A) (2): *“Only Voting Members may be elected to an office. In the event that an office cannot be filled by a Voting Member of the Band Boosters, the Executive Board may approve, by simple majority, a Supporting Member of the Band Boosters to be eligible for election to an office.”*

“Supporting Members” are defined in Section IV (B) (1) of the bylaws as either alumni/parents of alumni of the band program; or, interested adults who want to support the band program.

Let the record show that the amendment to Article VI (A) (2) has passed by a simple majority.

Item Three: Amendment to Article VIII Section D

Article VIII Section D lists the Appointed Board Position Members as: Uniform Coordinator, Volunteer Coordinator, Hospitality Coordinator, New Member Coordinator, Color Guard Coordinator, Pit Crew Coordinator, and CFPA Liaison.

The Executive Board has proposed amending the bylaws to add the following Appointed Board Positions: Concert Attire Coordinator, Spirit Wear Coordinator, Stadium Director, Band Camp Coordinator, and Letterman Gear Coordinator.

Let the record show that the amendment to Article VIII Section D has passed by a simple majority.
